

Call for an Expert 4/12/2013

Background

Transparency International-Greece (TI-Greece), the Greek Chapter of Transparency International, in cooperation with the Transparency International chapters in Lithuania, Italy and Latvia, under the coordination of the Transparency International EU Liaison Office, is implementing the project “Engaging the EU Presidencies in the Fight Against Corruption”, with financial support from the Prevention of and Fight against Crime Programme of the European Commission (DG Home Affairs). This transnational advocacy project will engage with the rotating EU Presidency to facilitate the exchange of best practice in policies to fight corruption and related crimes in the EU.

Under the project framework, TI-Greece is looking for an **expert** who will be able to support the chapter in the implementation of the following project activities:

- (i) monitoring and comparing the Greek government’s commitments and actions at EU and national level;
- (ii) sharing information and collaborative advocacy with the project partners;
- (iii) real-time monitoring the EU member states’ positions in the Council and the implementation of anti-corruption policies at national level.

The project will last for 2 years from the 1 August, 2013 to 31 July, 2015. The Greek Presidency period is 1 January – 30 June 2014.

Description of the Services to be provided:

- Collect evidence and track the activities and the commitment of the Greek Council Presidency to the anti-corruption agenda.
- Conduct a quantitative and qualitative assessment, evaluating the anti-corruption track-record of the Council of the EU under Presidency.
- Support the chapter to monitor the implementation of EU Anticorruption agenda at national level.

Expert Qualifications



- Relevant background in European Studies (required)
- Proven expertise in political-institutional analysis, with particularly strong knowledge of the EU institutions (required)
- Proven commitment to practical policy reform and evidence-based advocacy in the field of anti-corruption and good governance (required)
- Good command of English, written and verbal (required)
- Proven ability to write succinctly and for a non-academic audience (desirable)
- Experience in working with/applying quantitative indicators and rating methodologies (desirable).

The winning offer will be selected by a panel of TI-Greece staff and management.
