

Call for Offers Infographics development 15/7/2014

Purpose of the Call

Transparency International-Greece (TI-Greece), the Greek Chapter of Transparency International, in cooperation with the Transparency International chapters in Lithuania, Italy and Latvia, under the coordination of the Transparency International EU Liaison Office, is implementing the project "Engaging the EU Presidencies in the Fight Against Corruption", with financial support from the Prevention of and Fight against Crime Programme of the European Commission (DG Home Affairs). This transnational advocacy project will engage with the rotating EU Presidency to facilitate the exchange of best practice in policies to fight corruption and related crimes in the EU.

Under the project framework, TI-Greece is calling for offers for the development of infographics for the presentation of the evaluation of the Greek Presidency (Scorecard).

Deadline for offer submission: 29/7/14

Selection Criteria

Winning offers will be selected by a panel of TI-Greece staff and management.

Applications submitted under this Call for Offers will be assessed against the following criteria:

- 1. Experience in the field of the service (30 points)
- 2. Time of delivery (20 points)
- 3. Bid price (50 points)
